## **LOCAL WORK GROUP MEETING**

On July 26 Melanie Shull, of Aiken SWCD, and Robyn Amie, of NRCS, directed LSWCD's Local Work Group to discuss the resource concerns faced in Lexington County. Light refreshments were served during the two-hour meeting to keep the participants fueled as they outlined the most pressing concerns facing landowners and producers in Lexington County.

It wasn't long before both white boards were filled to the brim with concerns. NRCS separates resource concerns in to four main groups pasture, cropland, forest and animal waste/poultry. Our Local Work Group (LWG) identified 6 – 8 issues for each category then worked to narrow down the top three priorities in each category. Some issues, such as erosion and water quality, have caused concerns in more than one category.



### PASTURE

1. Management
2. Fencing
3. Vegetation health

### CROPLAND

1. Soil Health
2. Erosion
3. Water quality/  
quantity/Irrigation  
efficiency

### FOREST

1. Plant Productivity
2. Forest Health
3. Land conversion

### ANIMAL WASTE/POULTRY

1. Waste collection and  
containment
2. Water Quality
3. Erosion

While our LWG worked diligently to outline the problems NRCS has the large task of trying to address them and thankfully they offer many programs to help residents of Lexington County such as:

- EQIP (Environmental Quality Incentive Program) – an incentive program designed to encourage people to implement good conservation practices like stacking sheds and cover crops.
- CSP (Conservation Stewardship Program) – 5-year contract to encourage stewardship. This program enhances conservation practices that are that landowners put in place through EQIP.
- CRP (Conservation Reserve Program) – 10 to 15-year contract through FSA that assists agricultural producers in preventing environmentally sensitive agricultural land from being farmed or ranched.
- ACEP (Conservation Easement Program) – has 2 components: agricultural land easements and wetland reserve easements.

### **PUBLIC HEARING**

Hollow Creek Watershed budget for FY 2023 - FY2027 has been adopted.

### **BOARD MEETING**

The Board of Directors met August 4 and they discussed: fence line maintenance, invasive Vasey grass on the dam structure, election of 2 Directors in the November election and the possible change in hazard classification by DHEC.

### **DHEC DAM SAFETY MEETING**

The Hollow Creek Watershed met with DHEC to discuss changing the Dam's hazard rating. After much discussion the Board accepted DHEC assessment and made plans going forward.

## **NRCS MEETING**



On July 28<sup>th</sup>, SCACD took the initiative to work with Mr. Tillman, the Southeast Regional Conservationist for NRCS, on coordinating four meetings to hear from landowners and conservation districts who have experienced challenges as it relates to landowner service issues.

The meetings had representation from SCACD, Conservation Districts, landowners, federal congressional and senate staff, and other conservation partners. Through these stops, Mr. Tillman listened and gathered the concerns from all parties, in which he was very receptive. He voiced his support to address the concerns and dialogue has begun with SCACD on plans for improvement.
